# Civic Association Issues

#### CCCA Meeting: September 26

What a great meeting this was! Arlington County's unofficial historian Kathryn Holt Springston gave a slideshow presentation on the history of the Crystal City area: "Crystal City: from swamps, forts and brickyards to skyscrapers. This was not dry history, it was an engaging, informative demonstration of how the area has changed over the years, including the outline of the Potomac River and the swamps that became Crystal City and Long Bridge Park. #### Uber/Lyft Parking Lot on S. Eads Street

After months of public pressure, the County finally agreed to hold a community meeting on the traffic congestion caused by vehicles exiting and entering the airport Uber/Lyft Lot on S. Eads Street. The three civic associations in the 22202 zip code--Aurora Highlands, Crystal City, and Arlington Ridge--had been urging since May the closure of the entrance/exit on S. Eads Street and the reopening of the old gate on Route 1. As background, in April 2018 the Metropolitan Washington Airports Authority (MWAA) began operating a dispatch lot for Uber/Lyft vehicles on South Eads Street, near Fort Scott Drive. MWAA relocated the lot to the Eads Street site to make room for their "Project Journey" construction project, but the move has resulted in increased traffic congestion in this area. Representatives of MWAA and the Virginia Department of Transportation officials also attended.

The PowerPoint presentation showed that the County has made progress with two phases. Phase I is a temporary fix (for about 50% of the problem) to open the Route 1 gate for left-bound traffic to the airport ramp, by means of a temporary span-wire signal control on Route 1. VDOT has issued a permit and work is expected to start the first week of October and take 1-2 weeks. Phase II would solve another 20% of the problem but cost \$250,000 in funds that are not now as a capital improvement project. It would take 12-14 months, including underground utility survey, potential easement, design, VDOT review, and construction. <u>A new website for the project will be</u> <u>available some time in the next week and available</u> <u>here.</u>

# Crystal City Development and Planning Issues

#### (Editorial) Crystal City Development Paralyzed While Waiting for Amazon Decision

Most Crystal City residents are aware that our area is in the running as one of Amazon's finalists, when they expect choose a headquarters location by the end of the year. While an arrival of Amazon would also create demand for residential buildings, the first priority for land-owners is to be positioned to convince Amazon that there is plenty of existing and near-term office space that would match their needs. So right now, land-owners are hedging and, above all, holding off on committing existing and new buildings to other types of use.

As the main example, the plans for converting the office building at 1750 Crystal Drive to an exciting building for residential use, after a one-year approval process, have now been halted. JBG Smith may come back and resuscitate those plans during the next five years, but for now they are instead focusing on renovating the existing building, both internally and through 'reskinning'. (The plans for a grocery store and a movie theater in the same block are not affected). Similarly, the expected action on the approved tall residential tower at 23rd and Crystal Drive, which we reported about last year, has guietly been halted. And while plans for low-rise residential buildings in the PenPlace parcel (opposite WholeFoods) are being pursued, they are known to be a 'Plan B', which would quickly be dropped if Amazon were to appear and then quite likely have an interest in the entire PenPlace block.

#### (Editorial) Save the Full 18th Street Park

For a long time now, JBG-Smith has pursued plans for introducing a specialty grocery store and an Alamo cinema drafthouse on Crystal Drive between 15th and 18th Street. **This has the full support of our Civic Association.** Their preference to hold off on existing plans for converting the office building at 1750 Crystal Drive to a residential building, is also fully understandable, given the apparently imminent decisions from Amazon. Modified plans were approved at the Site Plan Review Committee September 17, with approval by the County Board to be requested at their October 20 meeting.

HOWEVER, all along, we have resisted an additional part of the overall package which is totally inappropriate in terms of both substance and process. The existing plans



for Crystal City underscore that "open space" is the scarcest aspect in our community. Thus, we enthusiastically support creation of an 18<sup>th</sup> Street park, which was envisaged in the 2010 Crystal City Sector Plan. Yet, JBG-Smith has stubbornly insisted on occupying a large and prominent part of the open space in the park at the corner of Crystal Drive and 18<sup>th</sup> Street with a two-story "retail building" over

the proposed second entrance to the Metro station with a building that will be unsightly and disruptive of the view from Crystal Drive--without providing any satisfactory justification other than their economic interest. This building was never envisioned in the 2010 Crystal City Sector Plan and will definitely cut into green space. The loss of the midblock open space park on the second level above the Crystal Square Apartments Building, which will disappear for construction of the Alamo Drafthouse, makes preservation of the full 18<sup>th</sup> Street proposed park critical, at least in the short term, given there are no funds for park design and construction for the planned second Metro entrance.

Moreover, JBG-Smith has refused to provide the kind of transparent outreach process to our community which has always been offered for such open space projects. Instead, recently, they have been requesting through the coUrbanize electronic process that people send in support blindly for the two-story building, without their realizing that they are supporting reduced open space. So there has been no chance for residents and others to evaluate whether there is any excuse or merit in the notion of shortchanging us on open space. This heavy-handed approach is not acceptable and any decision regarding the open space MUST be postponed until all options have been discussed in the community, especially as it is clear that the actual implementation of the open space is well into the future. No excuse for being in a rush! .

This is something like a poison pill in the JBG package to the County Board for October 20; do NOT support it blindly in the coUrbanize process! Be aware that you then implicitly would be supporting a reduction of valuable open space!'

We will continue to oppose that part of the plan since they can construct the interior improvements of 1770 Crystal Drive without impacting the open space.

#### Voting Precinct 006 Finds a Home!



For those voters in the north part of Crystal City, it's been a frustrating experience to locate our voting precinct in the last few years. Following renovation of our long-time venue in Waterpark Towers (1505 Crystal Drive) and a temporary move to Crystal Place

(1801 Crystal Drive), Management decided not to accommodate our precinct any more. So we spent a year in the Crystal City Underground Gallery where we were welcomed but which caused great confusion with Precinct 50 in Crystal Plaza for voters in the southern part of Crystal City.

Now, thanks to an agreement between the County and JBG-Smith, voters got a notification in August that our new (and hopefully permanent) precinct location is 251 18h Street. This is the red-colored Wells Fargo building which you can access from the plaza, two doors facing the Metro, and from an elevator in the Underground across from the restrooms near Rite Aid.

## Construction contract approved for final phase of Crystal Drive two-way conversion

This month the County Board approved the construction contract for the Crystal Drive two-way conversion's final phase, which will convert Crystal Drive between 26th and 27th Streets South to two-way operation. Construction is expected to begin in late 2018 and last approximately nine months.

The project is designed to improve traffic circulation patterns in Crystal City. In addition to the two-way conversion, improvements will include a loading area near the Hyatt Regency hotel, a new right-turn pocket for northbound Crystal Drive onto 26th Street, a bike lane on southbound Crystal Drive and sharrows on northbound Crystal Drive. There will be one vehicle traffic lane in each direction on this section of Crystal Drive. 27th Street South will also be converted to twoway traffic from Crystal Drive to Route 1.

This project is the third and final phase of converting Crystal Drive from one-way to two-way travel, as planned in the 2010 Crystal City Sector Plan. Upon completion, Crystal Drive will be a two-way street from South Potomac Avenue/27th Street South up through 12th Street South. <u>View the project page.</u>

#### **Clark Street demolition update**

Since the Clark Street structure above 15th Street South was demolished in July, crews have been performing some demolition work on the northbound Route 1 bridge over 18th Street South, on the right edge of the bridge deck. This work will allow the contractor to build a new traffic barrier wall along the right shoulder area of Route 1. The concrete barriers that currently separate Route 1 from South Clark Street were constructed on the Clark Street side and need to be replaced as elevated Clark Street is removed.

In the coming weeks the contractor will continue work on the new Route 1 traffic barrier wall, resume traffic signal work at the intersection of 20th Street South and Route 1, and continue hauling off concrete material. The next detours for this project will occur during removal of the Clark Street bridge over 18th Street South. This work has not yet been scheduled, but there will be a two-week advance notice before the detour starts. <u>View the</u> <u>project page</u>

#### ART 43 schedule changes effective Sept. 30

On September 30, schedule changes will go into effect for the ART 43 bus route that operates in your neighborhood. The changes include time adjustments to improve connections to Metroway, Metrorail, and other regional service providers. The northbound stop at Court House Metro Station (Wilson Blvd and N. ### A half-million square feet for HQ2 by the end of 2019? That's still Amazon's goal

Amazon.com Inc. (NASDAQ: AMZN) is holding to its goal of meeting the initial phase of its second headquarters in 2019, but it could be hard-pressed to hit that target unless it inks a deal for the space soon — no matter where HQ<sub>2</sub> lands. The requirement for at least a half-million square feet by the end of next year, included in the request for proposals the Seattle-based ecommerce and cloud computing company's issued last September, hasn't changed, according to a company spokesman. But building out that much space in a year and change could be a tall order given the time, materials and manpower needed, real estate experts say. The half-million square feet is just the initial requirement toward a much larger footprint of 8 million square feet or so expected to take until, 2027 or more to fill out. Read more here.

If Amazon chooses a site in the D.C. region for HQ<sub>2</sub>, that would suggest its initial requirement is more likely to be

met with existing space rather than new construction. There's plenty of vacant space in areas like Crystal City, as I examined with the Northern Virginia installment of my Hunt for HQ2 series, meaning the turn-around time would be quicker than a site that requires more prep work before construction can start on a new building. **Read more here.** 

### Here's what Jeff Bezos finally had to say about HQ2.

Amazon.com Inc.'s second headquarters will be ... decided by Dec. 31. That was the response the retailing giant's CEO and founder, Jeff Bezos, gave to fellow billionaire and The Carlyle Group LP (NASDAQ: CG) cofounder David Rubenstein when asked in an interview about its yearlong search for its so-called HQ2, a \$5 billion, 50,000-employee endeavor that has 20 markets around North America, including Greater Washington, vigorously vying to host it. A man who needed no introduction, in fact, got many September 13, including from JBG Smith Properties CEO Matt Kelly - whose company's new affordable housing initiative was one of the night's biggest sponsors and, incidentally, is one of the landlords rumored to be high on an HQ2 wish list with its Crystal City and Potomac Yard real estate holdings. VRE presented an update to the September 5



Transportation Commission and the September 25 County Board meeting. The materials that were presented were essentially the same as the June 6 public meeting updated for comments received

#### (Editorial) - Decision on New VRE Location Now Seems a Foregone Conclusion

Our community's focus has been on getting the new station to be located behind office buildings, rather than directly in the backyard of two residential buildings. However, VRE and County have persisted in their arguments that the location behind the 1801 and 1805 Crystal Drive residences is absolutely necessary. Judging from the VRE presentation to the County Board a few days ago, and especially the reactions from the Board, it appears clear that they have dismissed the issue of alternative locations, and are instead moving ahead with the details of final design. Moreover, there were statements to the effect that there will be no negative impacts on the two residential buildings, so that there would be no need for remedies or mitigation. As of this moment, we are not aware of any action still being pursued separately by the Crystal Park Condominium. The only consolation right now is that VRE still has not obtained funding for actual construction, so action does not seem imminent.

#### **Painted Bikes and Pinwheels**

Who put up the painted bikes with flowers and street painting from 12th to 18th Streets? Here's the definitive answer. The developer JBG Smith did this as a "small mini intervention" project to link Pentagon and Crystal Cities and create some "buzz" for their development projects in an interesting and more attractive way. The work was done by Ground Swell, a company of architects, landscapers, and artists from Philadelphia.

JBG has now replaced the bikes with colored, twirling



The bikes have been moved to a wooden fence on the north side of 12th Street near S. Fern Street location for the eventual PenPlace project.

#### New Restaurants on 23rd Street

Café Italia has been reincarnated as **Federico Ristorante.** Freddie (of Freddies Beach Bar) bought Café



Italiano, renovated it, and has reopened it as Federico Ristorante Italiano, at 519 23<sup>rd</sup> Street. Although open for a few weeks in September, the big opening is scheduled for Sunday, October 1, with an ice

cream social from 3-5 pm.

We also understand that **Los Tios Grill** - which describes their food as "fine tex-mex & salvadorean" - is coming soon to 23rd Street! With two locations in Alexandria, they're already a local favorite, with their homemade sangria and house specialty.

#### Metro chooses contracting team to build Potomac Yard station

Metro and the city of Alexandria have selected a contracting team to build the Potomac Yard Metro station, with an anticipated opening of late 2021 or early

2022. Potomac Yard Constructors, a joint venture of Halmar International and Schiavone Construction Co., have won the \$213.7 million contract, the Washington Metropolitan Area Transit Authority and Alexandria announced Monday. Both companies are "wellestablished subsidiaries of global construction companies," according to a release. The \$320 million station, serving the Blue and Yellow lines, is the driving force behind the redevelopment of the Potomac Yard area, dominated by 7.5 million-square-foot overhaul of Potomac Yard Center. Station construction is expected to start in the spring of 2019, after the city solicits public input on design changes — including improved access from the south to its lone entrance. Work should be on the fast-track next summer when WMATA temporarily shuts down all Metro stations south of Reagan National Airport for platform work. Read more here.

#### **Crystal City Store Closings**

**Taylor Gourmet** closed all 17 of its DC-area stores Sunday, September 23. The November 6, 2018, midterm election is fast approaching, but in Arlington County, eligible voters can line up to vote absentee in-person at the County Courthouse beginning September 21 through November 2, from 8-5 (until 7 pm October 30 to

#### County Manager Warns of Another Tough Budget Year

Arlington County faces an estimated budget gap of \$20-35 million for its 2020 fiscal year, which could require cuts to County services, increased taxes and fees, or a combination of the two. County Manager Mark Schwartz provided the news in a briefing to the County Board at its Sept. 25 meeting. He said that County revenues are forecast to grow by a modest 1.5 percent, while expenditures for the County's current set of programs are anticipated to grow twice as fast. <u>A</u> <u>Virtual Town Hall: FY 2020 Budget meeting</u> will be held October 17 from 7-8:30.. #### (Editorial) The County's Financial Situation Goes From Bad to Worse

### Be prepared for both a tax hike and reduced County services and investments.

When preparing the budget for the current fiscal year, the County early anticipated a \$ 20 Million gap between expected revenues and anticipate expenditures, and there was a sense that this would not be the end of problems. But the County Board had already issued an edict that a hike in the real estate tax rate was out of the question. So a partly temporary fix was put in place: almost half of the gap was closed through cuts in programs and services. But another substantial portion was "papered over" through accounting gimmicks, moving money between different types of funding. So it was now not surprising to hear County Manager Mark Schwartz reveal at the outset of the process for the next fiscal year, that the situation has gotten considerably worse. The gap is this time expected to be in the \$ 20-35 Million range, and that is before the exact requests from the schools system are known. Office vacancy rates and a decline in revenue also from the residential side have contributed. Moreover, Moody and other credit rating agencies have started reminding the County that the reserves have been kept at a level lower than what is desirable and should be built up, in order to avoid the risk for downgrading of County debts.

It is clear that further, more substantial cuts in services and programs will be needed. County staff will need to be reduced through attrition. And, above all, a tax hike, perhaps a substantial one, now seems unavoidable. While the discussion about the County's Capital Improvement Plan (CIP) has not yet started, it is very likely that resources for investments in high-density areas requiring substantial growth, like Crystal City, will be even more limited than last time. This could be expected to create a substantial dilemma, when the land-owners and private investors will want to move forward with development projects and then need to rely on County support for infrastructure and other County investments. The County's unwillingness to recognize explicitly that areas such as Crystal City subsidize the low-density areas of the County and are vital to the County's financial situation, will yet again become an obstacle.

#### Medicaid to Cover More Arlingtonians

The Arlington County Board voted unanimously on September 22 to accept state funding that will help pay for additional staff needed to process an expected flood of new applications for Medicaid under the state's expanded program, <u>Cover Virginia</u>. The Board authorized the County Manager to accept \$277,057 in state funding, money that will fund ongoing staff and operations in the County's Department of Human Services associated with determining eligibility. In the coming months, the state will automatically enroll those now covered under the <u>Governor's Access Plan</u>, who meet residency requirements, and <u>Plan First</u>, a state family planning program, with their coverage beginning in November 2018.

The County expects to begin processing new applications in November and anticipates some 7,000 new Medicaid applications. Of those, about 3,000 are expected to qualify. Currently, about 12,500 households, representing about 18,400 persons, are enrolled in Arlington in one of Virginia's two medical assistance programs: Medicaid or the Family Access to Medical Insurance Security Plan. <u>Read more here.</u>

#### Arlington to Study Dockless Bikeshare Bikes, Scooters

The Arlington County Board has approved a nine-month demonstration program to evaluate dockless bikeshare bikes and electric stand-up scooters, referred to as shared mobility devices. The Board voted unanimously September 25 to start the trial on Oct. 1 and ban scooters from sidewalks and trails. No one younger than 16 will be allowed to rent them. Companies renting the dockless bikes, e-bikes and e-scooters will have to pay Arlington a one-time \$8,000 fee for each category they offer and will have to agree to provide data on usage, trips and where the vehicles are parked. Arlington is also limiting the speed of scooters to 10 mph and bikes to 15 mph. The District is running a similar pilot program until December, and Alexandria is likely to consider its own regulations in the next few months, Arlington transportation officials said. #### (Editorial) Pedestrians - You Need to Watch Your Back More Than Ever!

Over the years, pedestrians on Crystal City sidewalks and crosswalks have become uncomfortably alert to the dangers created by bikers who ignore traffic lights and rules or generally show a lack of concern. But more recently you are likely to have noticed the influx of electric scooters, electric bikes and also skateboards. This development is now likely to 'explode' after the County Board just approved a formal testing program for nine months, encouraging vendors and regulating the number of electric vehicles in the Arlington mix of transportation modes.

However, the program features do not include any focus on the safety for pedestrians and others who may encounter the new vehicles when and there the least expect it. (You should be aware that electric bikes are allowed on sidewalks, whereas the scooters must stay in the street or bike lane.) The somewhat cynical notion is that hazards and remedies will instead become clear during the test period. But as the County will not have the resources to monitor or enforce regulations, it will be up to all of us, out of self-interest, to be diligent in reporting incidents and dangerous behavior. <u>ArlNow.com reports</u> on Arlingtonians reacting.

#### ART Bus 20<sup>th</sup> Anniversary

This fall Arlington is celebrating ART's 20th Anniversary of serving the County! Arlington Transit -- ART began providing bus service in the fall of 1998 with its initial route in Crystal City. ART supplemented the Metrobus system and helped to connect Arlington neighborhoods to Metrorail stations. This year's decal must go on the lower left side of the windshield, just to the right of the inspection sticker.



Starting next year, Arlington drivers won't need to display a car decal on their vehicles for the first time in decades. The County Board voted unanimously September 25 to end the requirement that owners of vehicles parked in Arlington use a sticker to prove they've paid personal property taxes. The "motor vehicle license fee" associated with the decal, which helps the county pull in about \$5 million each year, will remain under the Board's plan. But starting July 1, 2019, the county will now rely entirely on license plate readers to track whether drivers are up to date on their taxes.

### Arlington Gauging Community Satisfaction with County Services

Arlington County is conducting its fifth Countywide, statistically valid community survey to measure satisfaction with major County services and to gather input about issues facing the community. The results will enable County officials to assess performance across many County agencies and services. They also will be used to guide management decisions, inform budget development, identify areas for improvement, and ensure the best possible customer service. The County conducted its last such survey in 2015. The 2018 survey will be mailed to approximately 8,500 randomly selected Arlington households in all parts of the County. ## Arlington Schools Make a Connection that Counts

Arlington Public Schools (APS) is kicking off the 2018-19 school year with a brand-new connection— <u>ConnectArlington</u>. Thanks to a yearlong collaboration, 40 Arlington school facilities are now up and running on the County's own fiber optic network. APS made the switch from a commercial provider to take advantage of ConnectArlington's high-speed, dedicated network for digital telecommunications and broadband services. ConnectArlington connects County and Schools facilities together, providing secure and cost effective Voice, Video and Data services. As a fiber optic network, ConnectArlington has virtually unlimited potential to deliver digital services, meeting today's needs and laying a robust foundation for the future. #### Permanent Drug Take-Back Boxes Collect Hundreds of Pounds of Prescription Medications

In June, Arlington County installed three permanent drug take-back boxes to address a crucial public safety and public health crisis facing communities across the country – prescription drug abuse. In the first three months of the program, the public safely disposed of 407 pounds of unused, unwanted or expired prescription medications. Due to the success of the program, the police department is exploring expanding the program to provide residents with additional access to safe and secure disposal locations.

#### Arlington Tourism Revenue Hits Record \$3.3 Billion in 2017

Tourism revenue for Arlington reached a record \$3.3 billion in 2017, a 4.5 percent increase over 2016,



according to the U.S. Travel Association. Arlington has led Virginia counties in visitor spending since 2009. Tourism generated nearly

\$92 million in local tax receipts, benefiting County programs and services, as well as state tax receipts of \$123 million. Local tourism-supported jobs totaled 26,321, nearly 400 more than in 2016. Among other accolades in 2017, Arlington was named by Expedia as the third "Super Cool U.S. City," and one of the "Happiest Cities in the United States" by National Geographic magazine. Arlington also received a 2017 Readers' Choice Award from ConventionSouth magazine, recognizing it as a top location for meetings and conventions in the South. Read more here.

#### National Project Journey Update Escalator and Stairway Closure Near Delta and United Ticket Counters

One of six sets of escalators and stairs connecting Terminal B/C Ticketing to National Hall (concourse level), is permanently closed. Delta and United passengers using the ticket counters can reach the security screening checkpoint from other escalators, stairs or elevators. Other escalators open; minimal impacts expected.

In 2021, National Hall will be reconfigured to a connected <u>post-security terminal</u> that allows ticketed passengers to move freely between all gates in Terminals B and C. <u>View advisories on our website</u> When <u>Project Journey</u> is completed in 2021, two new 50,000-square-foot buildings with security checkpoints will replace three smaller checkpoints currently serving Terminal B/C – increasing the post-security space to include all of National Hall and its premier shops and restaurants for ticketed travelers. In addition, a new 14-gate concourse will replace Gate 35X – ending the need for travelers to ride buses to board regional jets parked outside. Concourse amenities will include jetbridges, holdrooms, concessions and an American Airlines Admirals Club lounge. <u>Read more here.</u>

### Officials unveil new facial recognition system at Dulles International Airport

With much fanfare, officials on September 6 unveiled a new system that eventually will replace boarding passes with facial scans for international travelers at Washington Dulles International Airport. Instead of pulling out their passports and handing over a boarding pass, travelers will instead have their faces scanned. That photograph, shot by an iPad mounted on a stand, will then be matched with a collection of photos maintained by the U.S. Customs and Border Protection agency. If the photos - from passports and visa applications - match the one taken at the gate, the traveler will be cleared to board. U.S. citizens can opt out of being photographed, but non-U.S. citizens are required to have their pictures taken. Images of U.S. citizens are held for 12 hours and then discarded. Travelers who declined to have their faces scanned will have their identity confirmed manually. Read more here.
