COVID NEWS

Free Testing at Aurora Hills

Beginning Wednesday, January 13, free, no referral testing available daily from 12-8 pm. Aurora Hills Community Center and Barcroft Park. Tests are offered at no cost and do not require a doctor referral or government identification, regardless of insurance or immigration status. Participants will be asked for insurance information, if available, so insurance providers can be billed, but no co-pay from participants will be required. Walk-up testing is available, although residents are encouraged to make an appointment on the Curative website. Kiosk service is available in English and Spanish. COVID vaccination Update

On January 22 Virginia Hospital Center started canceling all first dose vaccination appointments from January 26 onwards. Most of these were for 75+ in the 1b category. The ensuing panic that occurred following the VHC email cancellations was addressed on Saturday by Arlington County officials, starting with the [County Board meeting](#) with hosted Dr. Reuben Varghese, Arlington's Public Health Director. Record with CDC for Vaccination Side Effects

V-safe is a smartphone-based tool that uses text messaging and web surveys to provide personalized health check-ins after you receive a COVID-19 vaccine. Through v-safe, you can quickly tell CDC if you have any side effects after getting the COVID-19 vaccine. Depending on your answers, someone from CDC may call to check on you and get more information. V-safe will also remind you to get your second COVID-19 vaccine dose if you need one. January 27 CCCA Meeting

JBG has selected Clark Construction as its contractor for 1900 Crystal Drive. Clark is noted for its good social outreach to the community on MetPark. They are looking forward to finally breaking ground in late February, 2021. The project team will present a brief overview of the development, walk through details and logistics associated with the upcoming construction process, and answer questions. Crystal Houses and Housing Affordability



Great News! The Washington Housing Conservancy has bought Crystal Houses on S Eads Street with a major grant from Amazon and JBG Smith will manage it. The conservancy's mission — and the Crystal House project — aim to create spaces for individuals and families who may make too much money to qualify for government housing assistance but do not earn enough to afford high-demand real estate markets. With Amazon's flexible capital, WHC was able to execute the purchase of Crystal House in under two months, an expedited timeline for commercial real estate transactions. WHC's finance partner, the Washington Housing Initiative, and Impact Pool, created by developer JBG SMITH, provided commercial real estate expertise and an additional loan of \$6.7 million.

Amazon announced its Housing Equity Fund, a more than \$2 billion initiative to preserve and create more than 20,000 affordable housing units in the Puget Sound region in Washington State, Arlington, Virginia region, and Nashville, Tennessee—three communities Amazon calls home. The first investments include \$381.9 million in below-market loans and grants to the Washington Housing Conservancy to preserve and create up to 1,300 affordable homes on the Crystal House property on S. Eads Street. Over the next five years, rent prices for 75 percent of the units at Crystal House will drop to help residents who are making less than 80 percent of the area's mean income of \$126,000. SPRC for 2000/2001 Clark/Bell Site Plan

This is Block M, AKA Crystal Plaza Square that has been through 2 Long Range Planning Committee sessions and the first of two SPRCs is scheduled for February 18. The focus of that meeting will be about: 1) the Underground; 2) open space; and 3) S. Bell bike lanes. The VDOT Route 1 Multimodal Feasibility Study

VDOT held the first Public Engagement Meeting December 16 for the public to review existing conditions; hear about public survey responses; and ask questions and provide input. The purpose of this feasibility study is to identify enhanced multimodal connectivity and accommodations along Route 1 (between 12th Street to 23rd Streets) to meet the changing transportation needs of the Crystal City and Pentagon City communities. As this area's commercial and residential densities continue to increase, transportation plans will need to address the wide-ranging needs of pedestrians, bicyclists, transit riders, motorists, and other users while maximizing the safety, convenience, and sustainability of the system for decades to come. At this time, no construction funding has been allocated, so this study will not set design or construction dates. The timeline includes a second public meeting in March for more analysis; presentation of a draft report to the public in May and a final report in June. See the Study webpage [here](#).

Note: Participants in the December 16 meeting were surprised that VDOT is missing a lot of essential data and seems to see its charge is to determine if and how Route 1 can be brought down

to grade. The Livability22202 working group on Route 1 provided 19 pages of input and requests for more data. **We are organizing a Livability meeting with VDOT for the end of February. Details to come.**

Design work underway for Crystal City Metro Station second entrance

Last July, the County Board approved an interim agreement with a JBG SMITH subsidiary, JBGS/TRS, LLC, for development of 30 percent design documents for the second entrance at the Crystal City Metrorail Station. The engineering and design process kicked off in September, and the 30% design phase is anticipated to be complete this summer. Key elements of this phase include topographical survey, environmental analysis, and preliminary station design. This spring the County will host a public meeting as part of the project's 30% design phase, and WMATA will hold a public hearing as part of their review process. Pentagon City PDSP Update

The focus group consists of designated reps from neighborhoods, developers, and staff who are looking at existing conditions in the PC area, including approved plans/density, roads and pedestrian ways, transit, etc. The goal is to update and expand the 1976 plan resulting in a master plan for the PC area probably later this year though it may slide as the scope presents quite a challenge. Periodically there will be virtual public forums which anyone can attend. Scheduled virtual meetings are also posted there. The study is currently in Phase 2 through March for Preliminary Planning and Design. Phase 3 from February to April focuses on Work Product Refinement. Phase 4 from April to June will be Review and Presentation of Final Plan.

18th Street South project heads toward construction later this year

Design work has been completed for the 18th Street South Complete Street Project. The next step is preparing to release the construction contract for competitive bid. Construction is anticipated to start in late 2021. This project will rebuild 18th Street South between Fern and Eads Streets in order to continue the existing South Hayes Street protected bike lane further east. The intersection of 18th Street South and South Fern Street will be rebuilt to remove the slip lane and reduce crossing distances. Also, the project will reduce the amount of impervious surfaces, add stormwater retention, replace a water main and upgrade the streetscape. County Board Postpones Water Park Redevelopment

During its January 26 meeting, the Arlington County Board deferred consideration of JBG Smith's proposal to redevelop Crystal City's Water Park. CCCA Policy and Planning Vice President Chris Wimbush provided public comment on behalf of the Association conveying concerns expressed by our membership concerning the further commercialization of the park and the impact of the redesign on both bike and pedestrian safety. He noted that the CCCA appreciates the efforts of JBG Smith to explain its proposal to the CCCA on several occasions and then to the community in a public meeting on December 2 and to respond to community feedback. Although we are still concerned about commercialization of a casual use park and would prefer that the kiosks not appear at the front of the

park at all, a point that we've made many times to JBG Smith, we recognize that this is private property. As a result, we do appreciate the adjustments which JBG Smith has made in response to community feedback: e.g., turning the kiosks 90 degrees; opening more space between the two groupings to maintain more visibility of the park and fountain; and designing two sidewalks on both sides of the kiosks. There are many good open space ideas for the park: e.g., splash park for kids; leisure hill; event lawn; removal of the obstacle course of tree mounds on the current sidewalk; widening the sidewalks and providing one on either side of the kiosks.

Many participants raised concerns about a park staircase to the park which will cause safety problems with the biking and proposed pedestrian paths from the Mt Vernon Trail and the VRE station. Other issues were raised. The Board deferred the matter to a March meeting to permit additional public engagement from the relevant commissions/committees – including the Transportation Commission, the Park and Recreation Commission, and the Bicycling Advisory Commission.

CCCA Vice President Appointed to Arlington County Tenant-Landlord Commission

On January 26, 2021, the County Board appointed CCCA Vice President of Policy and Planning to Arlington's Tenant-Landlord Commission for a three-year term in a public interest seat. Wimbush, also serves as a delegate to the Arlington County Civic Federation and is a member of the ACCF's Task Force in Governance and Election Reform.

We Work Leaves/Hana Arrives

Coworking giant WeWork is planning to shut down its Crystal City location in February. It is not clear whether WeWork plans to close the residential space along with the coworking space — the former occupies most floors of the aging office building, while WeWork is housed in the top two floors.

However, Hana, a subsidiary of the real estate company CBRE Group, announced on January 28 that it has opened a new location at 2451 Crystal Drive — a stone's throw away from two of Amazon's temporary office spaces for HQ2 employees. Hana has initially opened one floor totaling more than 39,000 square feet. The floor includes private office suites and conference and events spaces, in addition to a traditional co-working space. JBG, which has been working with Hana on the project, says Hana's approach, and its abundance of amenities, complements the other co-working spots in Crystal City while addressing "the need for flexible, 'on-demand' office space solutions in a post-COVID-19 business environment." 
Residence Inn on Amazon's Future HQ2 Site Is Being Torn Down

The former Residence Inn hotel in Pentagon City is being deconstructed. While the demolition is not as dramatic as that of the Holiday Inn implosion in Rosslyn, it will similarly make a mark on a portion of the county's skyline. The demolition is taking place after the hotel, located at the corner of Army Navy Drive and S. Fern Street, was purchased by Amazon for nearly \$150 million in September. The tech giant plans to use the property to expand the second phase of its second headquarters campus. The first HQ2 phase is currently under construction, with an anticipated opening in 2023, while the county approval process for the second phase is expected to start later this year. A company representative tells ARLnow that demolition of the hotel is scheduled to wrap up this summer. The extra space will be used for extra amenities for Amazon employees and local residents, we're told. ([ARLNow.com](#))

Project HUG (Highlands Urban Park)

Our Livability Open Space project with the Friends of Urban Agriculture is entering the next phase of planning for spring planting. The garden demonstrates the benefits of implementing community-driven urban agriculture features throughout National Landing. It showcases modular, low-impact design principles, sustainable water management practices, and incorporates smart technology to collect agriculture metrics (daily solar exposure, temperature, moisture and soil health). We are working on the design of the water barrels and signage to explain the project and the plants. BID Report: Mobility Next



The [National Landing BID](#) has released a new report, [National Landing: Mobility Next](#), which examines how the downtown district's largest ongoing projects are interconnected as part of a grand vision to create the nation's most modern and efficient transportation network. Guided by a singular vision, the public and private sectors are together investing more than \$4 billion into the transportation network to meet the needs of current and future residents, employees, students, and visitors. The approach behind this transformation is rooted in four core principles:

- Strengthening transit capacity
- Expanding regional rail access
- Prioritizing human-scaled mobility
- Removing barriers to connectivity

Despite COVID-19 Contractor Impacts, Potomac Yard Metro Station on Track for Spring 2022 Opening

Alexandria is on schedule to see the Potomac Yard Metro station open in spring 2022, despite letters sent to the city from the contractor that work has been impacted by COVID-19. Contractors will be erecting the pedestrian bridge span over the WMATA tracks over the President's Day weekend, during which time Metro access between the Ronald Reagan Washington National Airport station and Braddock Road station will be shut down on the blue and yellow lines from Friday, Feb. 12 until Tuesday Feb. 16. Construction Underway for Second of Two Residential Buildings at Pentagon Centre

The second of two residential towers at Pentagon Centre, in Pentagon City, is taking shape at 15th Street S. and S. Hayes Street. This past spring, work began on The Milton, an 11-story building with 253 residential units and 15,541 square feet of ground-floor retail. It follows on the heels of a 26-story, 440-unit residential tower with 7,000 square feet of ground-floor retail called The Witmer (710 12th Street S.), which opened in July 2019. The Milton is set to be completed in 2023, said Geoffrey Glazer, the Senior Vice President for National Development of Kimco Realty, owner of the shopping center. The County Board approved the buildings in 2015 as part of Kimco's three-phase, 30-year development of Pentagon Centre. Phase one began with a parking garage near Costco. The project also includes a 9,000-square foot open space, according to a staff report. [Read more here.](#)

The Regal Potomac Yard Movie Theater is Being Torn Down

The first phase of Virginia Tech's massive Innovation Campus development is underway with the demolition of the Regal Potomac Yard movie theater, which closed in March due to the pandemic and never reopened. The one-story theater first opened in 1998, and "is an example of a typical multi-screen movie theater built during the late 1990's throughout the region," according to a city staff report. New Pedestrian Path and Lane Reduction Among Changes Coming to Boundary Channel Drive

A number of major changes are coming to Boundary Channel Drive and the I-395 interchange near Crystal City. The modifications include a shared-use walkway, pedestrian and bicycle access to the yet-to-open Long Bridge aquatics center, and reduction of four lanes to two. On January 23, the Arlington County Board voted to endorse the \$20.4 million Virginia Department of Transportation project. [Read more here.](#)

Restaurant and Store Changes

Sine Irish pub has closed. **Champs** sports bar — next to Siné — also closed its doors; it is now set to be replaced by **Nighthawk Pizza**, a beer-centric hangout, as Pentagon Row rebrands as “Westpost.” The Unleashed Pet Store on Pentagon Row closed January 23. **Unleashed**, a smaller-format version of the big-box Petco stores, opened at Pentagon Row in January 2013, replacing a Hallmark store. **Chick-fil-A** and a **Chase Bank branch** are moving into the ground floor of The Witmer, joining Arlington’s second outpost of **Wiseguy Pizza**. The local D.C. pizza chain opened the Pentagon location in June.

Project Journey Updates

So much is going on there that it's hard to keep up. **Join us at the CCCA meeting March 17 for a full update.**

"The 230,000-square-foot concourse on the north side of Reagan National Airport looks ready for passengers. The exterior walls are up. The roof is on. The terrazzo floor is almost in. And 11 of the 14 new jet bridges are being installed... The concourse is slated to open in July, but plans are in the works to do a 'soft opening' ahead of that date. An announcement is expected early next year." (Washington Post) The two-part, \$650 million modernization of Reagan National Airport is still expected to be completed this year, perhaps just in time for the majority of Americans to feel safe traveling through the air once again. The new north concourse, which will replace the despised Gate 35X, remains on schedule to open in July, according to a report on Project Journey released this week by the Metropolitan Washington Airports Authority. The secure National Hall project is not expected to open until the third quarter of 2021.

Helicopter Noise Study Issued by GAO

The GAO issued its report on Washington, D.C. area helicopter activity January 7, 2021, entitled "Aircraft Noise: Better Information Sharing Could Improve Responses to Washington, D.C. Area

Helicopter Noise Concerns." The major recommendation is that FAA develop a mechanism to exchange helicopter noise information with operators in the D.C. area. FAA agreed with GAO's recommendation. The summary and full report can be accessed on the GAO [website](#).
