# Open Space Report (Dec 2020) Fact Sheet Summary

The principles identified reflect the need for holistic planning to strengthen connectivity, natural ecosystems, and community-building:

- Improve hostile pedestrian environments and develop walking/biking loops throughout 22202
- Promote connectivity of open spaces from Arlington Ridge to Crystal City and Long Bridge Park
- Connect Crystal City to the natural areas of Roaches Run on the east side of the railroad right-of-way
- Identify goals for natural systems: reduce heat island effects, mitigate stormwater impacts, provide wildlife habitat, incorporate solar energy
- Increase shade trees, plant natives, and use plantings to provide seasonal color and interest year-round

# Agenda Item 2 Civic Federation White Paper on Equity in Arlington County Open Public Spaces

In the fall of 2020, the Arlington County Civic Federation's Parks and Recreation Committee used publicly available data sources to examine equitable proximity for County residents with respect to open public spaces (OPS).

- OPS is defined for this analysis as county parkland spaces where there are no "buildings, parking lots, and recreational facilities within the parks' boundaries," defined generally as natural "treed" areas as well as green "open" spaces that are open and available to the public without reservation or restriction.
- Walking Distance or Proximity to OPS is defined for this analysis as "total OPS approximate[d] at 10- to 15- minute walk zone for each resident or student."

#### Should we do it?


- JBG and/or County permissions would be needed

# Agenda Item 5 Furthering the Integrated Pedestrian Map

- What can we do?
  - Multi-stakeholder biophilia working group will refine the community vision for biophilia into input that can be turned into guidelines
  - NOTE: This is new ground not a lot of existing work in this area so this is not a forum where existing standards and policies provide much guidance.
- Where can we engage?
  - SPRCs highlight need to support connectivity to, from and through the sites
  - PDSP update Biophilia Working Group, PDSP Community Workshops

## Livability22202 Connectivity Map

- Need for better connectivity was emphasized by community in Livability22202 Workshops in 2019-2020
  - Connect the neighborhoods
  - Initiate and sustain community
  - Reduce reliance on car
  - Increase pedestrian safety
  - Connect with nature
- Connectivity among open spaces, residences, community facilities, transit nodes, and retail high streets
- Create connectivity with biophilic characteristics
  - Extend a park-like feel along the connections
  - · Not always aligned with the street grid
  - Increase opportunities for engagement with nature
  - Consider ecological characteristics as well




### Key Engagements in 2021

#### Pentagon City PDSP Update

- Guidelines for achieving connectivity
- Identification of critical routes metro access, parks
- Increase open space, improve access to existing open space
- Codify expectations on privately owned open spaces, connectivity through privately owned sites and alignment with county open spaces

#### SPRCs

- Amazon on Pen Place site, RiverHouse: Opportunity to demonstrate implementation of guidelines
- Crystal City Parks
- Route 1 Feasibility Study
  - Improving East-West access for pedestrians and bicyclists across Route 1
  - Extension of biophilic and eco-corridors across Route 1





# Biophilia Working Group

- Goal Work with community to develop inputs to the biophilia section of the PC PDSP guidelines, leveraging the open space report, biophilia principles and additional community input
- Timeline: 60 days
- Group: Elizabeth Gearin, Caroline Haynes, David Howell, Natasha Atkins, and several other urban naturalists/gardeners in 22202
- Draft approach: Starting from biophilic principles, (1) generate 22202 themes to identify specific biophilic characteristics, (2) identify specific gaps and opportunities in 22202 where connectivity and connection with nature is good, missing, could be improved. Refine the work product over a series of meetings and provide for community review, then provide to PDSP update as input to guidelines.

# Agenda Item 6: Roaches Run Clean Up Days

- Roaches Run Waterfowl Sanctuary and adjacent wooded area: a long contiguous natural space
  - Multiple custodians and owners: CSX, JBG Smith and National Park Service
- Recommendation: Develop a greenway between the GW Memorial Parkway and the railroad tracks from the south end of Crystal City to Roaches Run
  - Walking trail loop with multiple access points from Crystal City
  - Integrated into an overall system of pedestrian greenways in 22202
  - An extension of a 2012 NPS plan for Roaches Run
  - Multiple custodians and owners: CSX, JBG Smith and National Park Service



# Open Space: Roaches Run

#### Status

- JBG Roaches Run offer tied to 2525 Crystal Drive Site Plan
  - On hold pending outcome of building height study in 2021

#### Possible Next Steps

- Community clean up day April 2021(Annual Potomac River Clean-Up)
- Community outreach to determine the balance between community access and support for eco-system
- Engage Arlington County, Commissions, Property Owners to bring their technical expertise to the development of this open space

#### Other activities to consider are:

- Seeding wild rice for birds may be supportive of the migrating and overwintering birds
- A survey of the flora and fauna
- An invasive species removal activity

# Definitions Vary

- OPS is defined for this analysis as county parkland spaces where there are no "buildings, parking lots, and recreational facilities within the parks' boundaries," defined generally as natural "treed" areas as well as green "open" spaces that are open and available to the public without reservation or restriction. Walking Distance or Proximity to OPS is defined for this analysis as "total OPS approximate[d] at 10- to 15-minute walk zone for each resident or student. (CivFed White Paper)
- Open space is any open piece of land that is undeveloped (has no buildings or other built structures) and is accessible to the public. Open space can include: Green space (land that is partly or completely covered with grass, trees, shrubs, or other vegetation). Green space includes parks, community gardens, and cemeteries. (EPA New England)
- Open space generally refers to undeveloped land or water area. Specific definitions vary by jurisdiction, so local laws should be consulted for applicable requirements. (<u>USLegal.com</u>)
- In <u>land-use planning</u>, urban green space is <u>open-space</u> areas reserved for <u>parks</u> and other "green spaces", including plant life, water features -also referred to as <u>blue spaces</u>- and other kinds of natural environment.[1] Most urban open spaces are green spaces, but occasionally include other kinds of open areas. The landscape of urban open spaces can range from <u>playing fields</u> to highly maintained environments to relatively <u>natural landscapes</u>. (Wikipedia)

### Information For the Record

Arlington County's 2020 **Public Spaces Master Plan** (PSMP) dropped the term "Open space" as being too ambiguous; it uses the broader term "public space" and breaks it down into categories. It no longer uses the terms "passive" and "active" space. Instead, it says:

- **Public space** Space that supports recreation and leisure, natural resources, casual use, historic and cultural resources and is either publicly owned or has guaranteed public access including parks, plazas, trails, streets and recreation facilities.
- Casual use space: space that supports casual, impromptu use, including relaxation, reflection, informal activities or connection with nature.
- **Green space**: a publicly accessible area with a focus on natural vegetation, such as grass, plants or trees, that may include built environment features, such as urban parks, as well as less managed areas, including woodland and nature reserves.
- Plaza A pedestrian-oriented community gathering area primarily in high-density areas amid
  bustling streets and buildings to sit, play and relax that may, depending on its design, also serve
  as an event space. Often includes impervious surfaces and has close physical and functional
  relationships to surrounding retail, food and drink establishments.
- **Biophilic community** A place that cherishes natural features that already exist and works to restore and repair what has been lost or degraded. A place that emulates nature by incorporating natural forms into its cityscape and buildings, and plans and designs in conjunction with nature. A place that facilitates connecting humans with nature.
