- <u>Crystal Square Central District</u> Construction/Opening: *Tacombi* Taqueria will open in September; Solidcore is planning for August. *Grocery* still not announced but construction underway and may open by late 2021 or early 2022; *Alamo Draft House* has announced an opening in Spring 2022
- PenPlace Amazon HQ2: LRPC #4 met July 13; SPRC process to start in fall
- <u>Long Bridge Aquatic Center</u>: nearing completion; soft opening mid-August; grand opening September; watch for an invitation to register for a tour of the facility August 18 and 19.

- <u>241-251 18th Street renovation of plazas on both sides of 241;</u> under design by JBG; no impact on pending 18th Street park design between current and proposed Metro entrances
- <u>15th Street/Clark Bell Realignment, 90% design, comment period closed July 9</u>
- <u>Water Park redesign</u>: approved by County Board March 20; construction may start October 2021 with target completion winter/spring 2023
- <u>1900 Crystal Drive construction</u>: 3 years construction to 2024; started mid-April; Center Park and library tied to construction
- VRE Design for New Station: final design 2021-2022; award and construction 2022-2024
- <u>Boundary Channel (VDOT)</u>: award contract summer 2021; construction 2022; target construction completion fall 2023

Metro 2nd Entrance in Crystal City

Arlington County, in coordination with Metro, is proposing a second entrance to the Crystal City Metrorail Station. The station is one of the more highly used stations in Arlington County, and the proposed second entrance would provide additional capacity to accommodate more riders as the region continues to grow. The proposed second entrance would be located at the east end of the station – near 18th Street S & Crystal Drive – and would provide easier access from Crystal Drive, the VRE station and the Metroway transit station. In addition, the proposed second entrance plan includes elevator upgrades to improve compliance with the Americans with Disabilities Act (ADA) and provide more conveniently located elevator access. The proposed second entrance would also serve as an additional emergency exit. <u>Read more here.</u>

CC2DCA Project

On July 15 the County held a public meeting on the process for studying a potential pedestrian/bike connection from Crystal City to National Airport. In 2017 the BID funded a feasibility study, which created the idea for this connection. In 2019 the Commonwealth of Virginia dedicated \$9.5 million in federal funding for project planning, NEPA, and preliminary engineering, one of five projects to be funded as part of the agreement to bring Amazon to Arlington. As the project sponsor, the County has contracted the engineering firm Vanasse Hangen Brustlin (VHB) as consultants on a \$4.23 million contract in March to shepherd the project through that process. The Federal Highway Administration is the lead federal agency and VDOT is the joint lead agency.

Due to federal funding requirements, the project can't build on the BID study, but must start again from scratch, although the BID study can be one of the inputs. This means completing a full NEPA process that will take 3 years till 2023. NEPA means evaluating the environmental impact of the project in accordance with Section 106 of the National Historic Preservation Act and Section 4(f) of the US Department of Transportation Act of 1966 and ensuring that all federal regulations are followed. Step 1 in the NEPA process is a public survey to determine the purpose and need for the project. **The deadline for survey feedback is August 15.** Click here to take the CC2DCA Questionnaire. You can also send in comments to info@cc2dca.us. Step 2 is to develop and evaluate alternatives, and there will be a second public meeting in the winter of 2021-2022 to consider these. Once a preferred alternative is determined, there will be a third public meeting in the spring of 2023. The County hopes to get FHA approval in 2024.

Whenever the project secures the necessary approvals, Arlington should have most of the cash it needs to actually build it. Officials estimate a cost of about \$36 million, and the county currently has about \$27.5 million secured via state and regional transportation funding sources. The county itself would likely be on the hook to fill the gap. You can get more background and find the link to the July 15 meeting on the project page.

Dominion Power Has Started Construction on Crystal City Substation

Dominion Energy is expanding the power substation to upgrade the local system in advance of increased power demands from the massive Amazon HQ2 being built nearby in Pentagon City. Construction has begun and will continue through third quarter 2022 and the full project until second quarter 2023. See the <u>project page</u> for details.

VDOT Feasibility Report is Incomplete and Unsatisfactory

After 10 months of study and public meetings, VDOT released its feasibility report on Route 1 at the final Public Information Meeting June 16. No surprise: the recommendation is to bring Route 1 down to grade. The Livability Working Group released <u>a press release on June 27</u>. We also sent letters to

the <u>Arlington County Board</u>, <u>VDOT</u>, and our <u>Virginia legislators</u>. Subsequently on July 2, a representative group from the Working Group walked back and forth across Route 1 with County Board member Takis Karantonis to show what the concerns are from the perspective of those of us who live here. He was engaged and interested in our position and concerns. As we walked, we crossed Route 1 at 23rd as well as 20th so there were opportunities to provide the full Route 1 experience. We discussed the need for the underpasses to allow pedestrians, cyclists, and even motor vehicles to easily cross Route 1. He promised to consult with all stakeholders and get back to us.

Pentagon City PDSP Study Update

The goal is to update and expand the 1976 plan resulting in a master plan for the PC area probably later this year though it may slide as the scope presents quite a challenge. After Public Community Meeting #5, the study has entered Phase 4 (April to June): Review and Presentation of Final Plan. In case you prefer a full link, this is where all project documents and products are posted.

A <u>first draft plan has just been released</u> with a 2-week window in August for feedback. We also will be holding (virtual) Public Office Hours on Wednesday, **August 11** from 1-3 PM and 7-9 PM so that there are opportunities to ask questions and share back and forth about the draft plan. These office hours do not have a presentation, and are a "drop-in" style; the broad range of time is to attempt to accommodate different schedule needs. We are exploring creating a webform to allow for comments can be fully incorporated into a second draft plan that will be released in mid-September, concurrent with presentation of the draft plan to multiple County commissions over the following month.

A second draft will be released in September followed by a final Public Workshop/Open House and the beginning of County Committee/Commission briefings. Final Board consideration of the plan is anticipated sometime in the Fall. Upcoming meetings:

PenPlace Update

The fourth and final LRPC was held on July 13. Although the revised designs improved a number of issues, including space between buildings, a somewhat straightened east-west path through the center, and a new entrance at the middle of the Army Navy Drive site, there were a lot or remaining concerns. Planning Commissioner and community representatives alike said that they were more concerned about the lack of diversity in height of the block-shaped buildings which space between the buildings did not address: there is no sculpting. Although protected bike lines were welcomed on3 sides of the site, many insisted that 12th Street must have protection for bikes, especially since the original plan for an11th Street through the middle of the site has now been eliminated to favor a park. Although a new Army Navy Drive entrance was welcomed, it consists of steps and is not ADL compliant. The applicant (Amazon) via its architecture firm and JBG Smith developer, will need to

address some of these issues before an SPRC can be scheduled, presumably in September. The applicant presentation and the meeting recording can be viewed on the <u>project site</u>.

9/11 Eagle Scout Project Moving Forward



The County has approved a temporary project upgrade for the 9/11 memorial next to Fire Station 5 on 18th Street. Megan Mazel's scout troop and family began constructing a pentagon shape around the memorial on July 31 with lumber donation from Home Depot. A temporary plaza with mulch provided by the County was installed in preparation for the 9/11 memorial ceremony in September. A much larger permanent project is on hold due to cost, construction issues, and permitting.

Arlington County and Amazon to Facilitate Additional Affordable Housing on Crystal House Land Parcels

Amazon has announced its intention to assign its Option on the undeveloped land parcels on the Crystal House Apartments site to Arlington County for the purpose of developing new affordable housing. More than 550 units are planned to be developed as affordable for moderate- to low income households. The agreement also provides flexibility to the County to develop a portion of the overall unit count at other properties in Arlington County, if preferred. Amazon paid \$40 million to secure this land option when it helped the Washington Housing Conservancy (WHC) acquire the property in 2020 and will convey it to the County as part of an Assignment and Assumption Agreement. The County approved this on July 17 and will initiate a thorough, national-scale developer selection process with a master developer and sub developers to provide best practices for multiple-phase, mixed-income, urban block development and associated finance strategies. The project shall reflect goals of Arlington County's Affordable Housing Master Plan, the Housing Arlington program, and other related policies. Read the announcement here.

AT&T and JBG Smith Unveil Plans to Make National Landing the United States' First 5G Smart City at Scale

AT&T and JBG SMITH have entered into a letter of intent to deliver the first 5G Smart City at scale in National Landing. The first network infrastructure deployments are planned for the first half of 2022 and will expand with development of the community. They plan to work together to deliver one of the most robust network infrastructure deployments in any urban environment. 5G, with local area compute edges, could make National Landing a prototype for smart cities of the future and create a unified consumer experience across asset types. The area could also enhance offerings in mobility and self-driving vehicles, immersive retail and entertainment, and building automation and environmental sustainability. <u>Read more here.</u>

In support of advancing the creation of an innovation district in National Landing, the Arlington County Board approved July 20 signing an Indefeasible Rights of Use (IRU) Agreement with JBG SMITH, to use a share of County-owned excess dark fiber and conduit access in National Landing. This agreement will support and benefit businesses, federal agencies, educational institutions, the public and other organizations with cost-competitive and reliable access to high-speed wired or wireless (5G) data-transmission capacity to promote economic and community development. In exchange for conduit access for 75 years with an option of 24 additional years, JBG SMITH has agreed to provide Arlington with funds that offer an opportunity to support Arlington's digital equity goals. Arlington will receive \$2.8M upfront and an additional \$700,000 when connection is established to another section of dark fiber in the future. <u>Read the press release here.</u>

Arlington County to Resume Focus on Condo Affordability

Arlington County is looking to restart an initiative aimed at helping condominium owners stay in their condos that was halted by the pandemic. The Condominium Initiative, which is part of the county's Housing Arlington program, is focused on strengthening condo associations. A series of workshops this fall will include information on when capital improvement assessments should be performed and who should do them. Over the last couple of years, the County Board has received a growing number of accounts of deferred maintenance in certain condo communities, a trend that he predicted will continue as wages stagnate and fees climb. He added that the work should start now because sustainable solutions will require federal policies, which could take a few years to hammer out, he said. The board member said he wants monthly fees and assessments to be tax deductible just as interest on mortgages for homes is tax deductible. <u>Read more here.</u>

Homeowner Assistance Funds to Help With Mortgages

Later this year, Virginia will launch the Virginia Mortgage Relief Program, which will provide homeowners with assistance to prevent and/or ease mortgage delinquencies, defaults, foreclosures and displacement of homeowners experiencing financial hardship due to the pandemic. Financial hardship could include an increase in living expenses, child care, change in household size, job loss or reduction in income, etc. The Commonwealth of Virginia expects to receive approximately \$250 million in American Rescue Plan Act funds through the U.S. Department of Treasury. These funds are intended to support homeowners facing housing instability resulting from the COVID-19 pandemic. Virginia Homeowners will be able to request assistance when the program launches in early fall 2021. Future Amazon HQ2 Park Will Draw on Local Water Systems

Three water "elements" will be the focal points of the planned park space at PenPlace, the second phase of proposed Amazon's HQ2. And Kate Orff, the landscape architect designing this park, is drawing her inspiration from Roaches Run and the historic Alexandria Canal, as well as the churning waters of Great Falls Park and the sylvan streams of Rock Creek Park. <u>Read more here.</u>

Common Replaces WeLive at 2221 Clark/Bell

JBG Smith, main developer of National Landing in Arlington, Virginia, has selected Common to manage the 216 co-living units at 2221 S. Clark St., formerly the WeWork co-living community WeLive Crystal City. WeWork's spokesperson said it turned over management of the Crystal City WeLive in April and the Wall Street WeLive in June. The building's co-living units are now available starting at less than \$1,000 per month. National Landing, a new mixed-use walkable downtown and home of Amazon's HQ2 and Virginia Tech's \$1 billion innovation campus, is expected to see consistent demand for attainable, desirable housing for young professionals, according to JBG Smith. Crystal City Bike Network

In March 2020 the County Board directed the County Manager to develop a plan for improving the bicycle network in Crystal City within the next four years, by Dec. 31, 2024. The area covered by this plan is bounded by Richmond Highway (Route 1) on the west and Crystal Drive on the east, from the Alexandria border north to Long Bridge Park. The initial draft route proposed at the first public meeting was widely criticized for being dangerous, confusing, incoherent, and incomplete, and for not supporting a northbound protected bike lane on Crystal Drive. The revised plan is better, but still needs improvement. DES will use this feedback to finalize a Preferred Alternative for the Crystal City Bike Network, which will be presented to the County Board this fall for action.

Potomac Yard Metrorail Station Opening Delayed to September 2022

Metro announced a delay of at least five months to complete construction of the Potomac Yard Metrorail Station. Prior to the announcement, Metro notified the City of Alexandria of the delay. Metro engineers determined that the original design of the Automatic Train Control (ATC) systems, which was based upon specifications written by WMATA, did not meet all of the important safety requirements to ensure the safe operation of trains. The ATC system prevents trains from getting too close to one another and ensures trains always maintain a safe distance. The station, originally expected to open in April 2022, is now anticipated to open in or around Fall 2022 in order to complete the design and implementation of this safety critical system. Metro will work with its contractor to seek ways to prioritize completion of the ATC elements of this project. Alexandria intends to have its own expert construction consultant review the schedule to determine if there is a way to safely open this station earlier than September of 2022.

One year of lane closures in Potomac Yard

Starting today, much of Potomac Avenue where it runs through the Potomac Yard neighborhood will be cut down from four lanes to two for over a year as construction continues on the Potomac Yard Metro Station. The closures will run from E. Glebe Road, near the National Industries for the Blind, up to the city border with Arlington County.

Prioritizing Schools

The three 22202 civic associations-- Arlington Ridge, Aurora Highlands, and Crystal City--sent a letter June 23 to the County Board, voicing support for the Board to develop a plan for the creation of more K-12 seats in 22202. The letter, prepared by the Livability Schools Working Group, calls for the County to engage with APS with the aim of siting an elementary school within walkable distance of a significant percentage of children in 22202. It calls for a long-term plan in next year's CIP to address capacity issues at Gunston Middle School and Wakefield High School, through construction of existing facilities or new and innovative solutions leveraging partnerships with industry and commercial real estate developers. <u>Read the letter here.</u>

Cultural reopenings:

The Arlington Historical Society celebrated the grand reopening of the <u>Arlington Historical Museum</u> on July 4th with traditional holiday food, special tours, and a chance to listen to and meet with local leaders. The museum, located in the historic Hume School, is returning to its regular open schedule:

Saturdays and Sundays from 1:00 – 4:00 pm. View a video, Hume School: Past, Present, and Futures, recorded in May 2021, that discusses the history of the Hume School and AHS plans for the future. Donations, memberships, and visitors are welcome and appreciated.

The Arlington County **Aurora Hills Branch Library**, which shares the building at 735 18t St. South with the Aurora Hills Community Center, reopened on Tuesday, July 6. Currently, all five opened libraries are providing the same hours (Mon-Tues 10-5, Wed-Thurs 12-7, Fri-Sat 12-5) and services, including access to printers and scanners, self service pick-up, free WiFi, seating, and collection access and assistance. Study: Arlington Apartments Are Getting More Spacious

The average square footage of an Arlington apartment appears to be increasing, according to a new study from RENTCafé. Among 92 cities and jurisdictions, more than one-third are building bigger apartments now than they did five to 10 years ago, according to the website, which follows trends in the apartment market. And Arlington County had the seventh largest jump in unit size between 2016 and 2021. JBG Executive Vice President of Development Bryan Moll said the people seeking larger rental units fall into a few categories: first-time renters seeking units that fit roommates, those constrained by "the limited supply of affordable, for-sale housing," and new or growing families. <u>Read</u> more here.

According to Arlnow, a permit was submitted to the County for adding a Target store in the old Bed Bath and Beyond space, to "include retail sales of merchandise and groceries" but "no food or beverage preparation." No opening date is known. This would add to other recently added businesses, mostly eateries, including an ABC store, Mattie and Eddie's Irish pub, Bun'd Up & Wild Tiger BBQ pop-up, Napoli Salumeria, and Origin Coffee Lab and Kitchen. Opening soon: Nighthawk Pizza, featuring low-ABV beer; Lucky Danger Chinese restaurant; Mimi's Handmade Ice Cream.

ARLINGTON COUNTY ISSUES

Arlington County Board Adopts Capital Improvement Plan for Fiscal Year 2022-24

The Arlington County Board approved a \$1.25 billion three-year Capital Improvement Plan (CIP) July 20 that focuses on meeting Arlington's existing commitments, addressing critical infrastructure maintenance, and beginning investments in long-term plans and programs that will ensure sustainability over the years to come.

From Lee Highway to Langston Boulevard

It's official! The Board voted unanimously to officially rename U.S. Route 29 to Langston Boulevard within the boundaries of Arlington County between North Lynn Street to the western border of Arlington County with the City of Falls Church. Ranked Choice Voting Mock Election to be Held 8/3/2021

The Arlington County Office of Voter Registration & Elections will conduct a mock election using Ranked Choice Voting on Tuesday, August 3, 2021.

In 2019, the Virginia General Assembly allowed local councils and boards to be selected using an election method called ranked choice voting. This method allows voters to rank candidates in the order of their preference. The State Board of Elections is currently soliciting feedback on rules governing this election method. The public comment period ends 8/9/2021. The Arlington Office of Elections will conduct a mock election using ranked choice voting to gain a better understanding of this election method. The event will take place in 2 parts: Voting and Tabulation. The public is invited to attend both events to learn more about ranked choice voting.

DoD Commits to Looking at New Helicopter Noise Mitigation Strategies

Reducing local helicopter noise while conducting missions safely may be difficult, the Pentagon says, but the military is willing to try, according to a new report. The commitment and the recommendations conclude a Dept. of Defense report on the causes and effects of helicopter noise in the D.C. area. This document was completed as a result of Rep. Don Beyer's amendment to the National Defense Authorization Act, which included noise mitigation recommendations that Beyer and other regional lawmakers have sought for years in response to constituent complaints. DoD said it will also work with FAA to obtain flight track data trends to look at compliance with local flight procedures and helicopter routes, and address any potential corrective actions. Finally, DoD said it will work with the Army and Marine Corps to ensure "fly neighborly" and "fly friendly" procedures are being reinforced and examine the procedures currently being used. <u>Read more here.</u>
