### **The mysterious new grocery store in Crystal City sure looks like an Amazon Fresh store**

Is Amazon building a flagship grocery store near HQ2? Based on photos showing the inside of the under-construction store, it sure looks like it. Nothing has been announced, and both Amazon and building owner JBG Smith have been tight-lipped about the thus-far-unnamed grocery store that's coming to 1550 Crystal Drive, though rumors have swirled throughout the year that Amazon is behind the store. ### **County pushes for more greenery, accessibility in Amazon HQ2 Phase 2 designs**

The second SPRC took place virtually December 7. County commissioners welcome Amazon's latest revisions to plans for the second phase of its HQ2 in Pentagon City — but are pushing for more greenery and accessibility. Designs for Phase 2, also known as PenPlace, are wending through Arlington County's planning review process. Phase 2 will be anchored by a lush, futuristic building,

dubbed “The Helix,” and feature three, 22-story office buildings, three retail pavilions, a childcare center, a permanent home for Arlington Community High School, 2.5 acres of public green space, multi-modal pathways and underground parking. Amazon is massaging out the details with county staff, commissioners and community representatives to ready the plans for Planning Commission and County Board review, possibly in the spring. The tech giant has already updated the three office buildings, pathways and green spaces in response to requests for more architectural diversity and plantings. ## Route 1

Timewise, we are in Phase 2 when VDOT is supposed to conduct a number of studies related to their ongoing study of Route 1. Many of these studies were urged by the Livability22202 Route 1 working group and others. We hope to organize an update session January 19 at our next CCCA meeting with a VDOT update and a panel of residents reacting. In the meantime, the Commonwealth Transportation Board, a panel that manages state transportation funding and policy, voted unanimously December 1 to allocate \$134.4 million to fund the highway’s overhaul through 2028. The project, designed to bring at least some portion of the newly renamed Richmond Highway down to grade and make it more friendly to pedestrians, has a total estimated price tag of roughly \$180 million, but only if VDOT’s proposed option of bringing Route 1 down to grade at 15<sup>th</sup> and 18<sup>th</sup> Streets is enacted.

## Pentagon City PDSP Study

The planning study will update long-term goals for Pentagon City, establish parameters for future growth, and identify criteria to help review future redevelopment applications. The plan was presented at County commission and board meetings in December and public meetings will be held soon. Final comments were due December 31. The 4th draft version of the Pentagon City Sector Plan is anticipated to be released in the second half of January and will accompany the staff report for the February public hearings.

## SPRC #2 for PenPlace (Amazon HQ2)

A virtual Site Plan Review Committee meeting for [PenPlace](#) (Amazon HQ2) was held on December 6. The latest proposal received largely positive reviews from Arlington County and civic leaders who say the company’s design has incorporated public feedback. While the committee’s members voiced general agreement with much of the PenPlace design — including pedestrian access to Army-Navy Drive, green roofs on the office buildings, bird-proofing of the buildings, details of their façades and a priority on sustainability — many did agree on one key area for improvement: the need for even more trees and native plants on the site. In addition, committee members sought a higher priority for accessibility, offering suggestions to adjust the current proposed stairway on Army-Navy Drive. They also urged the company to work with county’s staffers who specializes in public art when creating the murals set to adorn the garage entrances. CCCA rep Judy Freshman reiterated concerns over the unimaginative rooftops that are not going to contribute anything to the skyline, a frequent issue that’s resurfaced in previous review meetings for the PenPlace design.

The Federal Aviation Administration has no issue with the height of Amazon.com Inc.'s proposed Helix, the towering conical structure that will be a major part of HQ2's PenPlace phase, closing the

book on questions raised by the Metropolitan Washington Airports Authority. The federal agency's review process required a monthslong aeronautical study, which concluded that the planned building, which rises 355 feet above ground level, "would not be a hazard to air navigation," despite its close proximity to Reagan National Airport. That's as long as it includes red lighting, according to a letter that the FAA sent Nov. 26 to Amazon's PenPlace design team.

The next step in the SPRC process is another meeting scheduled for **Jan. 24**, before Amazon can pass along its proposal to the Planning Commission and the Arlington County Board, steps projected for March. The SPRC will focus on transportation, sustainability, and construction/phasing. Following county approval, PenPlace is expected to open by 2026.

### Potential Big District Change for Crystal City

In December, the Supreme Court of Virginia unveiled draft maps for the Virginia House of Delegates, the Virginia Senate and the U.S. House of Representatives. The maps were drawn up by one Democrat and one Republican appointed by the court, after a non-partisan committee failed to complete the task earlier in the year. The maps propose an entirely new House district that essentially encompasses Arlington's Metro corridors, including Rosslyn, Courthouse, Clarendon, Virginia Square, Ballston, Crystal City and parts of Pentagon City. Currently, those neighborhoods are either part of House District 49 (represented by Del. Alfonso Lopez), House District 48 (represented by Del. Rip Sullivan), or House District 47 (represented by Del. Patrick Hope). None of these incumbents reside in the proposed newly-created House District 2, a VPAP analysis says, meaning there's an empty seat that could be filled by a political newcomer. [Read more here.](#)

### County, Amazon Partner to Preserve 1300+ Affordable Homes in Arlington

Arlington County and Amazon are making significant investments to help preserve more than 1,300 affordable apartment homes at the 60-acre Barcroft Apartment community for 99 years—one of the single largest affordable housing efforts ever in the region. At its Tuesday, Dec. 14, meeting, the County Board committed to a loan of \$150 million to support acquisition of the property. In addition, Amazon is committing \$160 million in a low-rate loan from the Amazon Housing Equity Fund to support the preservation. The County's and Amazon's funding will also support the developer in addressing immediate repairs, adding amenities, making property upgrades, and taking steps to improve residents' overall living environment. The County's commitment is the first public step in a

real estate deal that will be finalized later this month. The agreement ensures that the Barcroft property keeps its affordability for generations to come. After closing, residents currently living at Barcroft apartments will be assured they can continue to live in their homes and their rents will remain at the current rent levels for the first year. Future rents will be capped at no more than a 3% increase per year (up to 60% of the Area Median Income rent levels). [Read more here.](#)

### **Aurora Highlands property could become affordable housing for people with disabilities**

Melwood, which connects people with disabilities with public- and private-sector jobs and opportunities, currently runs a workforce development site from the building at 750 23rd Street S., in the Aurora Highlands neighborhood. It envisions redeveloping the property into a 100% affordable, 104-unit building with about 30 units set aside for people with disabilities. The five-story building would also house workforce development services and community programming. Melwood took an early step forward by filing an application for a Special General Land Use Plan (GLUP) study this week. The application says the study is needed because the property falls outside of any adopted county sector plan documents. Melwood requests that the county change the land-use designation from “public” to “low-medium” residential uses so that the property can eventually be rezoned for apartments, [Read more here.](#) In December County staff received a “Tier 1” Special GLUP Study application for the Melwood site located on 23rd Street. Staff will evaluate potential LRPC meeting dates later in 2022 to consider public feedback and evaluate if that request should proceed to the “Tier 2” analysis (which is the actual Special GLUP Study).

### **Virginia Redistricting Changes our Congressional District**

The Supreme Court of Virginia has unanimously approved new district maps for the House of Delegates, the State Senate, and the US House of Representatives. ### **County Fair to Remain at TJ**

The 2022 Arlington County Fair will be held at Thomas Jefferson Community Center and Park (TJ). Contributing factors for the site selection include that the community has enjoyed the fair at TJ for 45 years, 60% of the nearly 1,600 respondents of the site location public engagement preferred keeping the Fair at TJ and further review of the Long Bridge Park location indicated that it would not be able to accommodate the number and variety of rides the County Fair Board desires. ### **Debut of Long Bridge aquatics center makes waves among county swim classes**

In July, Arlington Public Schools launched the APS Aquatics School for students and residents, while the county opened the Long Bridge Aquatics & Fitness Center in August. APS's new program prompted the county's Department of Parks and Recreation to relocate most of its classes from local public high schools to the new facility near Crystal City. Since September, Long Bridge has been home to all county classes — save youth swim team practices — which officials say centralizes the county's program and serves more people. [Read more here.](#)

### **Free COVID-19 Tests Available at the Library**

In collaboration with the Virginia Department of Health (VDH), all Arlington Public Library locations will distribute free COVID-19 rapid antigen at-home test kits beginning Friday, Dec. 10, 2021. The test kits are available on a first-come, first-served basis and can be picked up from the service desk at each Library location. Neither proof of County residency nor a library card is required, and the kits are free of charge. Visitors are welcome to pick up test kits for both themselves and household members. Masks are required in all Library buildings - including when picking up a test. Anyone exhibiting COVID-19 symptoms should have someone pick up the test on their behalf. While the supply of test kits is currently limited, it will be replenished regularly. Please visit the Library to check availability.

### **New Bag Tax**

The Arlington County Board voted unanimously to adopt a 5-cent tax on disposable plastic shopping bags during its September 2021 meeting. Approval aligns with the County's environmental goals to reduce pollution and protect natural landscapes and comes as the City of Alexandria and Fairfax County make the same commitment to reduce plastic bag waste. The tax will take effect in all three jurisdictions on **Jan. 1, 2022**. [Read more here.](#)
