- This is an overview of cases in the [Crystal City Civic Association for 2022 v. 2023](#).
- Statistics were compiled using the originally reported Incident type and the “Reported Date” for date. Cases that were unfounded were excluded. Only cases with associated geospatial information are included.
- Please note the data is based on information available as of the query date. Data are subject to change upon further investigation. Some crimes/incidents may be reclassified at a later date.



- There were 117 cases reported in Crystal City in 2023 YTD (a 24% increase from 2022).
- 30 cases in 2023 have been cleared (arrest, exceptional, and non-criminal).



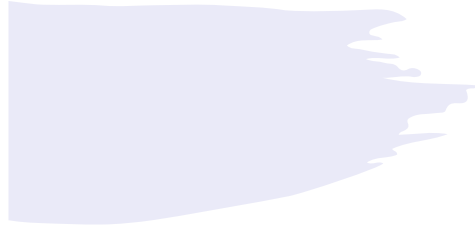
Notable Recent Cases

2023-01300249– Robbery – 426 23rd St S

Vehicle approached the victim's vehicle from behind; suspects got out and demanded the victim's vehicle at gunpoint. Suspects drove away in victim's vehicle.

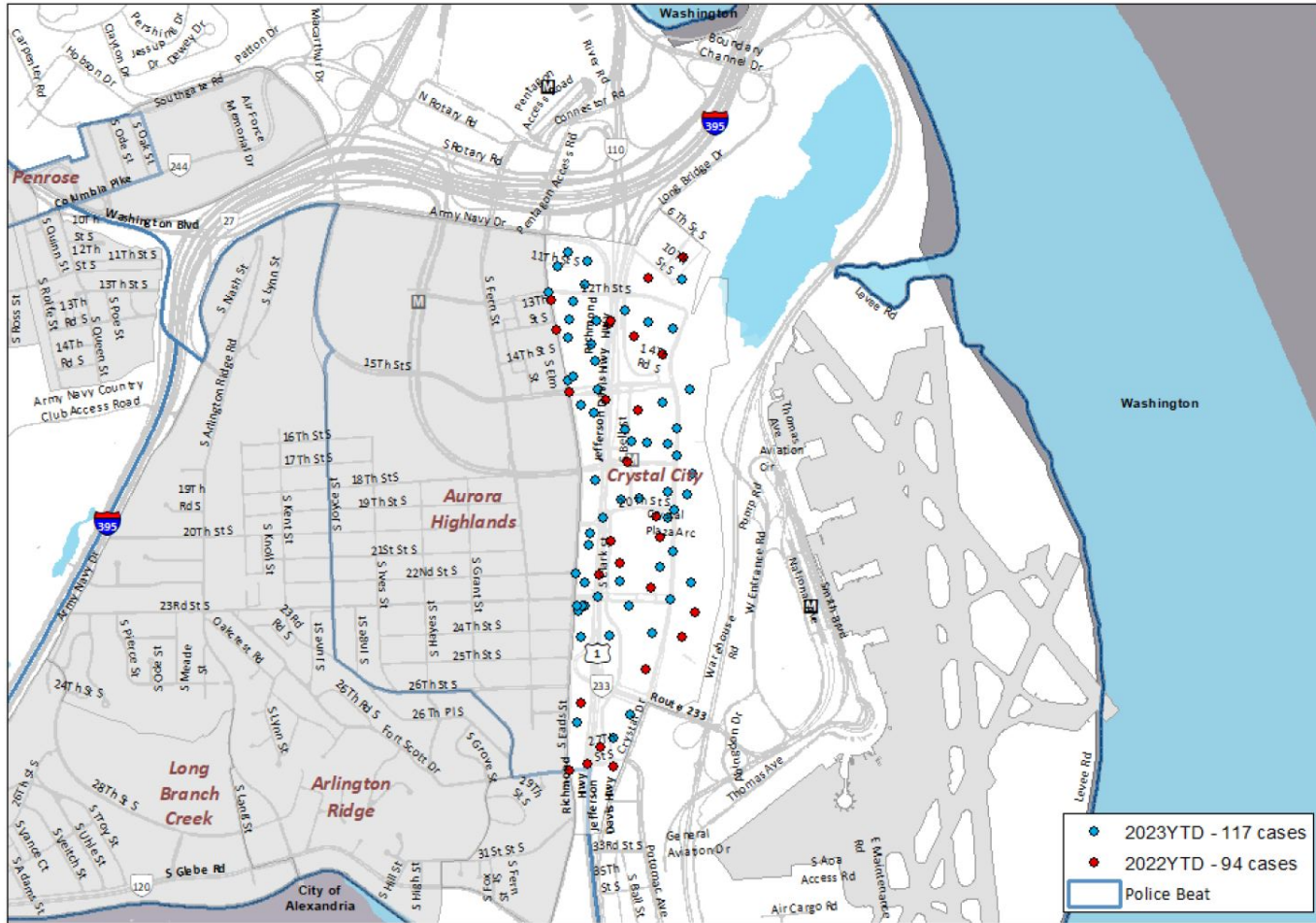
2023-01310196 – Burglary – 900 N Stuart St

Unknown subject(s) entered an apartment and took the victim's credit cards. The stolen credit cards were later fraudulently used.



**Other includes accidents, admin cases, child abuse, death investigation, mental health, missing person, noise complaint, obstructing justice, overdose, police info (non-criminal), runaway, solicitor violation, traffic offense, and CPS referral.*

IT'S TIME TO LOCK UP. 9 P.M. ROUTINE



At 9 p.m. each evening, conduct a security check and verify:



Vehicles, residences, garages, windows, gates and sheds are locked.



Tools, bikes, keys and other valuables are secured and brought inside.



Activate exterior lights, security cameras and alarm systems.

REPORT SUSPICIOUS ACTIVITY: Residents observing suspicious activity should contact the Emergency Communications Center at 703-558-2222 or dial 9-1-1 in an emergency.

Suspicious activity is an occurrence that is out of place in your neighborhood. Factors such as race, ethnicity, national origin, or religious affiliation alone are not suspicious. The public should report only suspicious behavior and situations rather than beliefs, thoughts, ideas or expressions.
