NOISE ISSUES: WHO TO CALL



What is the issue?



Loud Parties/Music

Indoor music is allowed if it cannot be heard inside from 20 feet away or outside 50 feet away



Animals

Heard at least once per minute for 10 consecutive minutes



Lawn Equipment

Lawn or garden maintenance using motorized equipment is not permitted during nighttime hours



Construction/Trash

Permitted during daytime hours; Noise exemptions provided by Code Enforcement



Live Entertainment/Restaurants

Each business has conditions on their live entertainment use permit



Nighttime Disturbance

Includes yelling, wailing, shouting or screaming that can be heard within a nearby dwelling



What time is it?

Any time day or night

7 a.m.–10:30 p.m., 7 days a week

10:30 p.m.–7 a.m., 7 days a week

9 p.m.–7 a.m. weekdays; 9 p.m.–10 a.m. weekends & holidays

8 a.m.–4:30 p.m., weekdays

Weekends, holidays, and 4:30 p.m.–8 a.m. weekdays

Any time day or night

9 p.m.–7 a.m. weekdays; 9 p.m.–10 a.m. weekends & holidays

Please Note: To enforce the Noise Control Ordinance, Code Enforcement, Police, or AWLA staff must witness the violation. Due to resources and response times, some issues correct themselves before staff can witness them and cite a violation.
